Sponsor must be a U.S. Coast Guard Officer or enlisted, active, reserve, retired, a USCG Auxiliarist, a DoT/DoD civilian employee GS7 or above, NF-3, any WS grade or WG12 and above and their dependents, or a commissioned officer in any branch of the U.S. Military Service, either active duty, reserve or retired.

Veterans who were awarded the Purple Heart. Veterans who are former prisoners of war. Veterans with service-connected disabilities (SCD) with VA certified rating 0-90 Percent. Caregivers or family caregivers of veterans (1) enrolled as the primary family caregiver in the VA's Program of Comprehensive Assistance for Family Caregivers (2) Eligibility limited to caregiver's active appointment period (one year; renewable). Family members of these patron group are not eligible.
